Subject: Handling of Appeals under MTCTE regime- reg.


In supersession of this office OM No. 5-5/2021-TC/TEC dated 12.02.2024 (enclosed), **Director (RC), TEC** has been designated as the Appeals Officer under Mandatory Testing & Certification of Telecommunication Equipment (MTCTE).

2. With reference to the section 'IV' of MTCTE Procedure (TEC 93009:2024), any Appeal against the decision taken by Authority in TEC w.r.t. the certification of Telecom Equipment under MTCTE may be sent to the Appeals Officer, in writing or on email to dirrc-tec@gov.in within 30 days from the date of decision taken by TEC.

3. Initially, the appeals shall be examined by Appeals Officer for its validity and if prima-facie they appear to be valid and having some substance, they will be taken up for further actions. The appellant will be informed accordingly.

4. Admitted appeals shall be placed before the designated Appeals Committee and the Appeals Committee shall make the final decision within a reasonable time. The Appellant shall be informed of the same by the Appeals Officer.



3. The Appeal shall be admitted if Appeal Officer satisfies that the appeal case prima-facie appears to be appropriate on ground stated by the appellant. The Applicant will be informed accordingly.

4. Admitted appeals shall be placed before the designated Appeals Committee and the Appeals Committee shall make the final decision within a reasonable time. The Appellant shall be informed of the same by Appeal Officer.
