Features- Applicants

- Applicant can apply either directly or Plan the use of street furniture through a GIS map & then apply
- On the map, an applicant can select the desired area and then create Geofence where he wants to plan infra. All street furniture available within the selected area with attributes & departments shall be presented.
- Applicant can select the desired street furniture then download excel/kml files and proceed.
- Applicant would need to fill up columns reg 5G Small Cell proposed to be deployed in the Excel sheet (Type, Weight, Power requirement, etc)
- He will see a grid showing Department wise selected street furniture. He can then select apply to submit the app to the desired department.

Recommendations of Working Group on " Cross Sector Collaborative Regulation between Telecom Regulators & Electricity Regulators"

- Secretary Telecom has shared the report of Working Group with Chief Secretary of States/UTs
- The power utility companies need to monetise their OFC or OPGW/ADS by leasing them.
- Guidelines for SERCs may be framed for revenue sharing if State transmission entities opt for engagement in telecom business
- 400 kv & 765 kv transmission line can be utilized for placement of Telecom
- Transmission assets such as electric substations lands & buildings can be utilized as location for placing Telecom equipment
- For deployment of small cells on electric poles, the poles would need several retrofit
- SERCs may be directed to install prepaid smart meters at telecom sites
- Telecom sites should be provided electricity connections under Utility/Industrial Tariff.
- DISCOMs should adopt ONE DISCOM-ONE-BILL-ONE PAYMENT policy
- Electricity consumption at each site may be allowed to be aggregated and offset with green power generated at locations.
