In exercise of powers conferred under the Central Telecommunication Act, 2023 by the Department of Telecommunication, Government of regarding to setting up of telecom infrastructure, the Telecommunication (Right of Way) Rules, 2024 dated 17.09.2024 have been notified, degrading the Indian Telegraph Right of Way Rules, 2016 and the Indian Telegraph (Infrastructure Protection) Rules, 2022, which are effective from 01.01.2025.
