Sub: Implementation of Right of Way Rules (RoW), 2024.

Ref: D.O. letter received from the Secretary, DoT, New Delhi vide D.O.No.5-6/ 2024 (186123), DT:11.11.2024. (enclosed)

Sir,

In the reference stated above, the Secretary, Department of Telecommunications (DoT), Government of India (Gol) informed:-

"...the DoT has recently notified the Telecommunications Right of Way Rules (RoW), 2024 in accordance with the Telecommunications Act, 2023. Further, it was informed that the Telecommunications RoW rules, 2024 are now mandatorily followed without any need for going through adoption process and the said rules would stand implemented w.e.f. 01.01.2025.

One of the important features of the Act is that its implementation has to be digital by design. Therefore, all the provisions of the Telecommunications (Right of Way) Rules, 2024 made under the Act have to be implemented in digital form. Accordingly, the centralised right of portal- Gati Shakti Sanchar, developed for 11 Stated / UTs and integrated with RoW portals of other 25 States / UTs is being upgraded.

...Alternatively, the State can also use Central RoW Portal for its use".

It has been approved by Hon'ble Lt. Governor of Delhi that the Telecommunications (Right of Way Rules), 2024 shall come into effect from 01.01.2025 in NCT of Delhi.

Consequent to the aforesaid, Delhi Right of Way (RoW) Policy for underground infrastructure and over ground infrastructure, 2023 dated 01.11.2023, shall cease to be operational in NCT of Delhi.

Further, Hon'ble Lt. Governor has also approved that Government of NCT of Delhi shall use Central RoW Portal.

Appropriate action may be taken accordingly.
