# Model Building Bye-Laws, 2016

#### Ministry of Housing and urban development (MoHUA) - Model Building Bye-Laws, 2016 on

"In-building access by telecom service provider"

- Dedicated Space for establishment of Telecom Infrastructure in all building
- Telecom Space/telecom room
- Entry points for TSP cables at entrance of building

#### Addendum to Model Building Bye-Laws, 2016 on "Inbuilding Access by Telecom Service provider" in March-2022

The **salient points** are as below:

- Making cities smarter
- In- Building and Gated Buildings Solutions
- Provision of Common telecom Infrastructure
- Access Permission to Telecom Service
  Providers/Infrastructure providers
- Common Telecom Infrastructure facilities should not be seen as a source of revenue, rather to facilitate digital connectivity at par with water and electricity connectivity
- Charges should be fair, reasonable, transparent and nondiscriminatory and should be on residential rates.
- No fee will be charged for Indoor Building Solutions/ Fiber to the Home Network. Charges may be levied for power

#### States/UTs may adopt above bye-laws

## **Indian Telegraph RoW Rules**

#### Indian Telegraph ROW Rules, 2016 and Amendment(2022)-Salient Features

- Uniform ROW Policy across the country
- Appointment of Nodal Officer by Appropriate Authority
- Standard Documentations
- Time limit of 60 days for approval, Deemed approval after 60 days
- Uniform fee
  - Underground Infra (OFC) INR 1,000/km
  - Overground Infra- Tower –INR 10,000/ tower
  - Overground Telegraph Line-INR 1,000/km
- An Electronic Application Process (Single Window System)
- Dispute Resolution

#### Indian Telegraph ROW Rules, 2016 and Amendment(2022)-Salient Features

- DoT has issued amendment to ITROW 2016 on 17th August 2022 incorporating provisions for Poles/Street furniture. The salient features are as below:
  - Administrative Fee for the establishment of poles Rs 1000 per pole for installation of small cells and telegraph line.
  - No **administrative charges** for installation of small cell and telegraph line on the immovable property under control or management of central authority
  - Licensee shall **restore** the damage incurred in case of establishment of poles for installation of Small Cells and telegraph line.
  - **Compensation charges** for usages of street furniture for installation of small cell, Rs 300 /annum for urban & Rs 150/annum for rural
  - **Compensation charges** for usages of street furniture for installation of telegraph line,Rs100/annum/street furniture
  - No compensation for establishment of poles for installation of small cells and telegraph line.

#### Indian Telegraph ROW Rules, 2016 and Amendment(2022)-Salient Features

- Permission for installation of small cells and Telegraph line, only Details of Street furniture along with structural certificate to be submitted
- No permission from any authority for telecom infrastructure on private property. Only prior intimation along with structural suitability certificate
- Self restoration- a Bank Guarantee amounting to 20% of restoration cost
- Restoration by authority- the cost of restoration shall be calculated at the rates prescribed by Central Public Works Department (CPWD) or Public Works Department (PWD) of the State/UTs.
- Opportunity to be heard before rejection

## **5G rollout in states**

#### Working Committee under SBC to be formed for following action

- Modalities for use of government infrastructure/street furniture for establishing telecom structures.
- Inventorisation of Street Furniture as per DPIIT OM dated 03<sup>rd</sup> march 2022, DPIIT OM dated 24<sup>th</sup> June 2022 and Broadband Mission dated 20<sup>th</sup> July 2022
- Finalizing the common Power consumption bill.

- State ROW portal should facilitate respective departments for street furniture approval online, including Bulk approval options.
- State ROW Portal should be integrated with the central ROW portal for street furniture.
- Designated Nodal officers for resolving the issue and Contact details shall be made publicly available.
- All pendencies to be tracked .

## 'Click Before U Dig' – soon to be launched

## Problem

- Nearly 10 Lakh Optic Fiber
  Cable Cuts/year across India
- Huge Economic Losses
  - Rs. 3000 cr/year wasteful expense for TSPs/ISPs
  - Inconvenience to citizens
  - Business losses

## Solution/App

- BISAG "Click before U Dig" App
  - Excavation route entered in App
  - App alerts utility owners
  - Shares contact details Diggers/ utility owners

### States/UTs

- Mandate all contractors to use this solution
- Mandate all utilities to map all their utilities (cables/pipelines)

#### LAUNCH STRATEGY & CURRENT STATUS

It will be implemented in phases.

- **Phase I**: With basic features of exchanging the contact details of the utility asset owners with diggers, it is proposed to be pilot launched in Gujarat and UT of Dadra and Nagar Haveli.
  - User AT report expected shortly, States to map their officials contact details. Can be made Live by mid of Sept 2022
- **Phase II**: After 2 months of Phase I, the pilot to be extended to all States/UTs.
- **Phase-III**: After 2 months of phase II, additional features and changes based on learnings during the pilot will be incorporated.
- All India Launch may be considered at Hon'ble PM level, as it will impact multiple sectors/departments across India

## **Responsibility of States**

- All utilities to be mapped on PM GatiShakti NMP with location/depth/width and contact details/ escalation matrix.
- States to ask all underground utility asset owners to register their assets on NMP viz.
  Electricity Cables, Water-pipe, Gas-pipe etc.
- All agencies (mapped or not) to be mandated to respond to messages from Click Before You Dig and take actions accordingly
- Digging to be allowed only using 'Click Before You Dig' and as per its terms and conditions.
- Charges in case of damage while carrying out work bilateral decision Arbitration can be provisioned.



- Fortnightly Regional Coordination Meeting Commitee(FRCM) being conducted by IROs to discuss pending proposals
- Total 423 Right of Way applications are pending with Forest Department across states/UT
- Science and Technology Department (Government of Madhya Pradesh) has taken a very positive step by making amendment in "Guidelines for establishment of Infrastructure to provide wire line or wireless based voice or data access services by TSP/ISP/IP Companies in Madhya Pradesh-2019".
- As per the amendment, the Telecom Service Providers/ Infrastructure Providers have to apply online application for seeking permission of forest land. thereafter, the District Collector would obtain the rights of the land from forest department.
- All states/ UTs may adopt similar practice regarding forest clearance
