- DIPA also suggested to fix the charges for usage of Government Building for deployment of telecom infrastructure.
- BSNL shared the concern of power cut in BharatNet GPs. A list will be shared by BSNL in respect of same.

In his concluding remarks, the Chairman of State Broadband Committee, Chief Secretary, Govt. of Chhattisgarh assured that all assistance will be provided by the State Govt. for timely roll-out of 4G saturation project. He also asked CGMT BSNL to expedite the progress of upgradation of BSNL 2G/3G Mobile BTSs to 4G soon after receipt of the equipment as the upgradation work can be completed quickly and this will bring a lot of relief to security personnel and the common citizen of the state.

He requested Department of Telecom to monitor the daily data consumption of all the mobile towers in Chhattisgarh State and to compare it with the national average. This will help in identifying the usage of telecom towers and in formulating policies for bridging the digital divide.

The meeting ended with thanks to the chair. Issued with the approval of Chairman, State Broadband Committee, Chhattisgarh.
