

Minutes of the State Broadband Committee (SBC) meeting held on 16.05.2022 at 12:30 PM under the Chairmanship of the Chief Secretary, Haryana.

List of participants is at Annex-1.

2. Additional Chief Secretary, Department of Information Technology, Electronics, and Communication (DITECH), apprised the officers about the progress made by various districts specifically after the last meeting chaired by Chief Secretary on 02 February 2022:-
3. It was informed that substantial progress has been achieved. Details of total applications pending in the state are as under:

Total applications pending as on 02-02-2022	: 2875
Total new applications received in State after 02-02-2022	: 2300
Total applications cleared as on 16-05-2022	: 4450
Total pendency of applications as on 16-05-2022	: 1046

(Includes 312 applications pending for more than 45 days)
4. Additional Chief Secretary, DITECH further mentioned that Haryana had moved to the Online System of applications for RoW permissions since 2018. All the RoW cases are in full sync with the GatiShakti Sanchar Portal (<https://sugamsanchar.gov.in/>) of Government of India. However, many States are yet to go completely online. Therefore, the State wise comparison as per GatiShakti Sanchar Portal dashboard does not depict a full & true national picture. As per the present data (which is incomplete since many State applications are still offline), Haryana ranks at No. 6 w.r.t. clearing in RoW applications with only 6.9% pendency.
5. Dr. Mahesh Shukla, Advisor/Senior Deputy Director-General, Department of Telecommunication (DOT), acknowledged the efforts put in by Haryana to clear pending the ROW applications and stated that they are working with States like Bihar and Uttar Pradesh to move all their applications from physical to online mode citing Haryana as an example.
6. Chief Secretary appreciated the efforts made by the IT department & DCs in the clearing of pendency and directed that the remaining 312 applications pending since 45+ days must be cleared in the next 3-4 days.




7. Chief Secretary also advised all the districts to get in touch with Dr. Mahesh Shukla Senior Deputy Director-General, Department of Telecommunication (DOT), in case there is any issue related to network connectivity in any district. It was further advised that Nodal officer CCIP, DITECH may be contacted any time regarding any issues with the portal.

(Action By: All the DCs and DOT/LSA)

8. Representative of the Digital Infrastructure Provider Association (DIPA) made the following comments:
- a. It was requested to waive off the Compounding charges as provided under the bye-laws 2013 of ULB:
 - i. Dr. Mahesh Shukla, Sr. DDG, DOT, informed that there are only a few such cases and they have already directed the ISPs to deposit the fees/ dues as the amount is very less.
 - ii. PS ULB also mentioned that the ISPs must pay statutory dues/penalties under the provisions.
 - b. It was also requested to consider the dish-like antenna installed on the tower as an integral part of the tower itself, which is required to communicate between different towers. Presently, some districts are considering it as a separate Dish Antenna and accordingly charging under the provisions of the CCIP policy.
 - i. Principal Secretary to CM mentioned that CCIP policy provisions are for such Dish Antennas which are installed separately and being used for distribution/communication, and which are not part of the tower equipment.
 - ii. Dr. Mahesh Shukla, Sr. DDG, DOT, mentioned that this unit is an integral part of the tower equipment and requested not to treat the same as a different Dish Antenna and levy charges accordingly.
 - iii. Chief Secretary agreed with the above views and directed not to levy any extra charge for any all integral components of a tower.

(Action By: DCs, DOT)

- c. It was further requested to waive annual charges by government authorities/local bodies for those locations where the tower is installed in private properties and ISPs are paying rent to individuals (private persons).

Chief Secretary desired that Principal Secretary ULB may look into the matter and resolve it.

(Action By: Urban Local Bodies)

9. Chief Secretary emphasised while discussing progress with all the districts that the Hon'ble Prime Minister is reviewing the matter in the next PRAGATI meeting scheduled for 25th May 2022 and therefore, all the pending cases must be resolved positively within the next 3-4 days.

(Action By: DCs)

10. Additional Chief Secretary, IT mentioned that in some cases department is wrongly selected by the applicant and requests are coming to the State Nodal officer for changes. In order to speed up the process, the facility to change the department is being extended to the DC login itself.

(Action By: Industry & Commerce/HEPC)

11. Additional Chief Secretary, DITECH also requested that the District Administration may try to close the RoW application within 30 days itself so that there is no pendency beyond 45 days. He further requested all DCs to share the departmental nodal officer's contact details (Name, contact number & email Id) with the State nodal officer, CCIP (Sh. Kamleshwer Keshri, 0952169539, kamleshwer.keshri@semt.gov.in) for needful follow-up and speedy disposal.

(Action By: All the DCs)
