

Minutes of Meeting held on 03.10.2023 at 04:15 PM under the Chairmanship of the Chief Secretary regarding State Broadband Committee (SBC)

List of officers who attend the meeting placed at **Annexure-I**

1. Head SeMT appraised about point wise agenda items and substantial progress accordingly.
2. Principal Secretary, CRID mentioned that State RoW Policy has been revised in accordance with Central Row Rules and an endeavour shall be made to process the draft for upcoming Cabinet Meeting scheduled for 11th Oct 2023 for approval.

(Action By: CRID Dept.)

3. Special Secretary IT, informed that CCIP policy is provisioned for deemed approval, if no discussion is taken in 45 days. The Standard Operating Procedure (SOP) has also been finalised illustrating the steps and timelines with process flows and communicated to the HEPC for implementation in Invest Haryana portal within a weeks' time.

Chief Secretary desired to implement the same at the earliest within timelines.

4. Nodal Officer CCIP apprised that the development of 5G Forms on the Invest Haryana portal has been successfully completed and also tested on the staging environment in accordance to the anticipated approval of the revised CCIP policy. It was apprised that the same shall be made go-live once the CCIP policy is notified.

5. Sh. Sanjeev Nagpal, Sr. DDG LSA requested for adaptation of rules mandating the use of CBuD. It was also informed that as on date 957 users mapped from 12 departments in state.

- i. PS CRID expressed his reservations on the mandatory use of CBuD Application as the data exchange is presently one way, i.e., from State to Department of Telecommunication (DoT). It was suggested that DoT may agree to share the telecom infrastructure database related to Haryana with the State.
- ii. Chief Secretary instructed the LSA to arrange a separate meeting with PS CRID specifically after working on the suggestion before the next SBC meeting.

6. Add. DG, LSA informed about the integration of street furniture data into the Gati Shakti portal, which is part of the State Master Plan. Furthermore, it was mentioned that the Department of Industries and Commerce serves as the Nodal Agency within the state responsible for implementing these changes.

Chief Secretary desired that LSA and the DoT team to submit a brief summary note regarding the agenda items post which a separate review meeting shall be convened with concerned departments under his chairmanship.

7. Director, LSA requested in meeting for constitution of committee for Digital Communication Readiness Index (DCRI).

Chief Secretary desired that a separate meeting may be arranged with the Secretary of Telecom along with PS CRID to discuss and address this matter more comprehensively.

(Action By: LSA, DOT/CRID)

8. During the meeting, the LSA flagged the issue of a high rejection rate for applications and apprised that several meetings have been held with TSPs/IPs to identify the reasons behind application rejections. It was suggested that there is a need to update the process and required documentation. Further, DG DIPA apprised the status of the telecom industry where presently there are approx. 25,000 towers in Haryana and the target is to reach 47,000 towers by 2024 in accordance to National Broadband Mission (NBM) and requested that the rejection rate must be reduced if this ambitious target is to be achieved.

- i. Nodal officer CCIP apprised that a drop-down menu has been introduced in the online portal which would allow to capture the actual reasons for rejections. The software level changes are in progress and the same shall be implemented once the changes w.r.t the CCIP policy are notified.
- ii. PS CRID advised that reports may be added in the portal to regularly monitor the same which should be made available to DCs and also at HQ level. These cases would also be shared with a TPA for independent audit to further streamline the system and reduce the rejection rate.

9. LSA, DoT requested the Committee to consider the implementation of a composite billing mechanism as per the advisory issued by GoI dated 24.05.2023.

- i. Representative from COAI informed about the promotion of renewable energy through green energy and presented information regarding the aggregation of loads within the same division to qualify for 100 KW eligibility.
- ii. Chief Secretary directed to outline the concerns related to the Power Department and organise a separate meeting to address these issues.

(Action By: LSA, DOT)

10. Other Points:

- i. Chief Secretary asked to assess the policy on 5G mobile phone use by state employees, considering costs, updates, and essential provisions.
- ii. Director, LSA suggested that state departments such as Education, Health, and Transport initiate 5G use cases in collaboration with the shared startup list.

The meeting ended with a vote of thanks to all the participants.
