# Minutes of the State Broadband Committee (8th) Meeting

The 8<sup>th</sup> SBC meeting was held on 04<sup>th</sup> March, 2024 at 11:30 AM. The meeting was chaired by the Special Chief Secretary (IT) to the Govt. of Assam. The list of members' / participants is attached in <u>Annexure-A</u>

The meeting started with the welcome address by Shri Pankaj Das, DDG(Rural), DoT Assam LSA. After having a brief round of introductions, a detailed presentation was given by DoT, Assam LSA on various important issues as per following agenda:

- 1. Review of USOF Projects: BSNL 4G Saturation project / RJIL 4G Mobile Project in 2 Districts.
- 2. 5G Roll out Initiatives.
- 3. Ensuring the use of CBuD App by all departments & agencies.
- 4. RoW pending issues.
- 5. DIPA/COAI /ISPAI issues.
- 6. Addl. Points: Tagging Important Events of the State & Submission of DCRI Data by State Govt.

The points discussed & decisions taken are stated as below:

#### 1. <u>REVIEW OF USOF PROJECTS</u>:

#### a. BSNL 4G saturation project:

i. BSNL 4G Saturation USOF Project status in Assam:

#### Next Phase:

Inclusion of all the left-out cases of 4G uncovered villages/shadow areas under USOF Saturation Project:

The information has been sought from all the districts in a specific format by DoT, but the same is yet to be received from the State. The IT-Department has informed that it has also written letters to the DCs thrice, but the information is not yet received from the districts. The Chair, considering the importance of the matter, directed the Secy-IT to take up this issue in the forthcoming meeting with the DCs (to be conducted shortly) and ensure submission of the compiled information to DoT at the earliest so that no 4G uncovered Village/shadow areas remain left out from inclusion in the 4G saturation scheme in Assam.

## 2. 5G ROLL OUT - INITIATIVES REQD:

a. Creation 5G Form and integration of State RoW portal: DITEC informed that 5G form has two modules: (i) installation of small cells by using TSPs' own poles and (ii) installation small cells by using existing street furniture. First module has been already created. The Chairman instructed state IT-Dept to take urgent measures to complete the process for the second module.

**b. GIS mapping of street furniture:** BISAG-N demonstrated the functioning of Mobile App for mapping the street furniture. DITEC enquired about the structural stability aspects to be incorporated in the App for mapping the street furniture. However, it was clarified that as the App is only for mapping purpose, the TSPs will be responsible for ascertaining the structural stability of the assets/Furniture from their ends. APDCL & the State Nodal Officer said that they are in contact with BISAG for further customizing the App for their specific needs which was consented by BISAG and will be available shortly. The Chairman asked APDCL and other concerned line departments to use this BISAG APP, which is free and being used by other states for mapping of their street Furniture, without further delay.
