1. At the outset of the meeting, the Chairman set the context of the meeting and also asked the Punjab LSA, DoT to report on the area wise deficiency and the phase wise roll out plan w.r.t. the smooth 5G roll out in consultation with the TSP's.

After rule 9, the following rule shall be inserted namely:- "9A Establishment of temporary overground telegraph infrastructure (1) In case of damage of any existing underground telegraph infrastructure for any reason, the licensee, whose existing underground telegraph infrastructure is damaged, may temporarily establish the overground telegraph infrastructure, in lieu of the damaged underground telegraph infrastructure, to restore the telegraph service for the period of sixty days from the date of reporting of damage of the infrastructure to the appropriate authority. (2) No fee or compensation shall be charged by the appropriate authority for the establishment of temporary overground telegraph infrastructure under this rule". 2.	In rule 10 of the said rules, in sub-rule (5), - (a) For the word and figure "rule 10B", the words and figures, "rule 10A and rule 10B", shall be substituted.	The expression of mobile tower, pole, small cell were applicable only to rule 10 & 10B as per GoI notification August 2022 however in Chandigarh RoW Policy, Feb 2023 the expressions are incorporated in chapter I, (2. definitions – i,j,k). Hence no amendment is required.
