### **Minutes of Meeting**

The second meeting of State Broadband Committee of J&K UT (SBC- J&K UT) was held on 19.01.2022 under the Chairmanship of Dr. Arun Kumar Mehta, Chief Secretary, Govt. of J&K UT. The meeting was attended by the following officers:

3. The meeting Started with the introduction of participants and welcome address by Sr. DDG, DoT, J&K LSA, Jammu. Following agenda points were discussed and decisions were taken:

- a) **RoW online Portal:** - Chief Secretary agreed for onboarding to the centralized RoW Portal. The administrative approval for this will be issued by the Secretary (IT), J&K UT.
- b) **Preparation of Agreed List of Uncovered Villages:** -In the meeting it was observed that there was a discrepancy in number of uncovered villages between LSA and UT administration. The Chief Secretary directed to reconcile the number of uncovered villages in a period of 15 days. The J&K LSA, DoT may coordinate with Secretary (IT), J&K UT in this regard.
- c) **USOF Tower Installation:** - Chief Secretary desired that all 88 USOF Towers are to be installed by the end of Feb, 2022.

- d) **RoW Pending Cases:** - The Chief Secretary assured that all the pending RoW cases will be cleared by the concerned authorities of J&K UT within 45 days. DIPa was asked to forward details of pending RoW cases to J&K LSA, DoT and Secretary (IT), J&K UT.
- e) **Provisioning of EB Connection at USOF Towers:** - Chief Secretary assured that the power connection would be provided at all USOF sites within 45 days. The list of USOF sites may be shared with Secretary (IT), J&K UT by J&K LSA, DoT.
- f) **Digital Map of village:** - The Chief Secretary conveyed that the maps of villages are available at <https://landrecords.jk.gov.in>. The same may be used by J&K LSA, DoT for village maps. In case of any difficulty, the issue may be taken up with Secretary (IT), J&K UT.
